



GUIDE TO E-RATE FUNDING 2025

FUNDING YEAR 2025-FORM 470

It's time to apply for 2025 E-Rate funding. This guide will help you navigate the application process with some of the key facts and dates for this funding window. USAC (Universal Service Administrative Company) had made Form 470 available for Funding Year 2025, but with the addition of needed updates on September 19 in the E-Rate Productivity Center (EPC). Form 470 for the next funding year, normally available as of July 1, had been delayed in 2024 awaiting the FCC's new hotspot order (FCC 24-76) to be published in the Federal Register.

New items on the FY 2025 Form 470 include:

- · Ability to request hotspot devices and wireless internet services
- · Enhanced options to request school bus Wi-Fi services and equipment
- The ability to upload RFPs and other documents to the Form 470 after certification, even if the original Form 470 had no attachment(s)
- An ability to cancel a Form 470

Training Schedule

New Funding Year 2025–Lending Hotspots

While you are waiting for these trainings, some quick points on how E-Rate lending hotspots will be handle differently than ECF did includes:

- 1. **C3 Budget**—A maximum pre-discount amount an applicant may request across three funding years, similar to C2 budgets
- 2. **Reporting**—Require usage reporting at 30, 60 and 90 days (with required action)

The hotspot budgets for both schools and libraries will be determined by the formulas below:

Independent School or District Budget = (student count $x = \frac{20 \text{ hotspots}}{100 \text{ students}} = x C1 \text{ discount rate} x 630

Library or Library System Budget = (square feet $x = \frac{5.5 \text{ hotspots}}{1000 \text{ square feet}} x C1 \text{ discount rate} x 630

Four important points should be noted concerning the school and library budget formulations:

- 1. Funding Years-Budgets will cover three full funding years, FY 2025-FY 2027.
- 2. **Student Counts**—Although Head Start, pre-kindergarten, and kindergarten students are deemed ineligible for funded hotspot services, student counts used for hotspot budget calculations will be the same as used for Category 2 budgets
- 3. **Yearly Per Device Amounts**—The \$630 factor reflects a \$90 hotspot equipment charge and 36 months of wireless internet service at \$15/month (\$90 + (36 x \$15) = \$630).
- 4. **Device Minimums**—The formulas above are to be rounded up to the nearest 10, which makes small schools and libraries eligible for at least 10 devices.
